

Coaches Compliance Checklist for Practice Field Release

1. RMA Complete - Head Coach and at least one other adult on your team

a. Teams must have 2 RMA compliant adults at every practice. In addition to the Head Coach, this can be an Assistant Coach, a Team Manager, or any parent volunteer of a player on your team that is willing to become RMA compliant and stay at your practices.

i. You MUST email NSCScheduler@outlook.com with the name of your second compliant adult so that we can verify it is completed on our reports.

2. NSC Coach Agreement – Needs to be signed by the Head Coach

3. NSC RTP Coaches Phase 2 Protocol - Needs to be signed by the Head Coach

4. 100% Team Registration and Payment

a. All players must be registered, and payment received to begin practices.

b. Contact registrar.girls@northshoreselect.org or registrar.boys@northshoreselect.org for status update information about registration.

5. RTP Practice Field Requests

a. Since practices during Phase 2 RTP are one day a week, for a shorter length of training time, the days/times that you request will look different than our normal requests.

Other teams that would like an earlier slot are welcome to request that time as well.

Deadlines

IF we have both Forsgren and 60 Acres fields available by 6/29, then the following deadlines are in place for compliance.

Fully Compliant by **Friday June 26th at 6:00 pm** = Practice Fields assigned for the **week of 6/29**

Fully Compliant by **Wednesday July 1st at 6:00 pm** = Practice Fields assigned for the **week of 7/6**
